



SITEONE LANDSCAPE SUPPLY, INC. ANNOUNCES LAUNCH OF SECONDARY PUBLIC OFFERING OF COMMON STOCK

ROSWELL, Ga.--(BUSINESS WIRE)-- SiteOne Landscape Supply, Inc. (NYSE:SITE) (the "Company") today announced the launch of an underwritten secondary public offering of 8,500,000 shares of common stock by selling stockholders CD&R Landscape Holdings, L.P., an affiliate of Clayton, Dubilier & Rice, LLC, and Deere & Company. The Company will not receive any proceeds from the sale of shares being sold in this offering. In connection with the offering, the selling stockholders expect to grant the underwriters a 30-day option to purchase up to an additional 1,275,000 shares of common stock.

The offering is being made through an underwriting group led by Deutsche Bank Securities, Goldman, Sachs & Co., UBS Investment Bank and Baird, who are acting as joint book-running managers for the offering. Additional book-running managers are Barclays, RBC Capital Markets, SunTrust Robinson Humphrey and William Blair. ING, HSBC, Natixis, SMBC Nikko and Mischler Financial Group, Inc. are acting as co-managers for the offering.
